#### **MAYOR'S REPORT**

Mayor Hrivnak reported the police department partnered with the school district to participate in PA Operation Safe Stop, promoting awareness of school bus stop safety issues; Officers Kapusta, Callen and Iachini received awards for bravery at the Senator John Heinz Law Enforcement Awards Luncheon on Friday October 21st; Trick or Treating activities went well without any significant incidents; Officer DeMarco conducted five traffic investigations; the traffic division issued 53 citations during the month, the department conducted a seat belt use information site at the high school; the department responded to 943 calls for service last month and the Mayor wished everyone a Happy Thanksgiving.

Intergovernmental Cooperative Committee with Plum School District- Mr. Thomas stated there was no meeting scheduled at this time.

Finance Committee – Mr. Dell reported the budget calls for a ½ mill tax increase, noting this is the first increase since 2007. The purpose of the increase is to establish a new EMS fund, helping them with capital improvements and to increase the street improvement fund. Mr. Dell stated the budget includes one SRO with the school district splitting the costs at 50%. Mr. Dell said he attended the Municipal Authority meeting and they plan on a slight increase in water and sewage rates for 2017.
