Intergovernmental Cooperative Committee w/Plum School District – Mr. Thomas announced that the meeting was scheduled for January 20th. Topics of discussion will be construction updates, roads, snow removal, USGA, delinquent property taxes, housing starts and the municipal authority rate increase.

Finance Committee – Mr. Dell reported the Borough had collected 100% of revenues, EIT came in higher than expected and lower fuel costs created a savings of \$98,000.
