Motion was made by Mr. Majernik, seconded by Mr. Seitz, to authorize the use of the remaining \$240,158 2016 GOB proceeds for the 2019 Storm Sewer Projects. Unanimously approved.

Motion was made by Mr. Majernik, seconded by Mr. Dern, to adopt Resolution No. 856-18 authorizing the Vision Finance Group Annual Lease. Unanimously approved.

Motion was made by Mr. Majernik, seconded by Mr. Anderson, to adopt the 2019 annual budget as presented by the Finance Committee. Unanimously approved.

**MAYOR'S REPORT** – Mayor Schlegel thanked Plum Resident Dave Johnson for preparing a Thanksgiving Dinner every year since 2012 for the police department.

Mayor Schlegel reported there were 993 calls for service during the previous month.

**INTERGOVERNMENTAL COOPERATIVE COMMITTEE WITH PLUM SCHOOL DISTRICT** – Mr. Thomas reported the committee met on November 5<sup>th</sup>; the SRO program will be discussed in executive session in January.

**FINANCE COMMITTEE** – Mr. Majernik reported on revenues and expenditures for the month; real estate taxes are at 96% of budget; cable TV franchise revenue will end the year \$19,000 under budget and the independent auditors will begin field work in January.

**ROADS, EQUIPMENT AND GROUNDS** – Mr. Pastor reported the Edgemeade storm water project has begun; the Short Street project has had some change orders and the leaf pickup concluded on December 7<sup>th</sup>.

**PUBLIC SAFETY** – Mr. Dern wished everyone Happy Holidays. Brian Maloney of Plum EMS reported they responded to 244 calls and Mr. Johnson provided Thanksgiving Dinner to his crew as well.

**PLANNING AND ECONOMIC DEVELOPMENT** – Mr. Odom reported 61 permits were issued resulting in \$19,393 in permit fees; the Planning Commission met in November to review changes to the zoning ordinance and the subdivision and land development ordinance and the staff is working with Peoples Gas on their proposed gas line replacement in Holiday Park.

**PARKS AND RECREATION** – Mr. Anderson did not have a report.

**PERSONNEL** – Mr. Seitz read a list of open positions on boards and commissions.
