MAYOR'S REPORT – Mayor Hrivnak reported there were 691 calls last month; Officer Conley was recertified in field sobriety; Plum Borough was ranked 6th safest community in the United States. Mayor Hrivnak suggested signs be installed at the entrances to the Borough recognizing this distinction. Mr. Dice suggested a contest be held throughout the school district to design a sign.

COMMITTEE REPORTS

Intergovernmental Cooperative Committee w/Plum School District – Mr. Nowalk said that the committee had not met this past month.

Finance Committee – Mr. Dell reported the Borough has not had to draw down on the TAN yet; Renton volunteer fire department did purchase land to be used for additional parking; RVD is still interested in phase 2 at the Renton Road site. Mr. Dell stated they will have a draft of the 2012 audit by the end of March.

Personnel and Management – Mr. Nowalk reported that Radio Station Y108 is running a contest for the best fish fry and Holiday Park volunteer fire department is in the lead.

Roads, Equipment and Grounds – Mr. Szarmach reported there were 18 snow or ice events last month; the department worked on pot hole repairs and repaired street signs. Mr. Szarmach stated the Borough has gone through 101% of their salt storage budget for this year.

Public Safety – Mr. Knopfel reported the fire departments are conducting weekly fish fry's and residents are encouraged to purchase street numbering signs from the departments.

Planning and Economic Development – Mr. Taylor reported 31 permits were issued last month, 62 inspections were conducted, and 15 violations were issued. Mr. Taylor announced a Plum Business Showcase to be held at the high school on April 16th.

Parks and Recreation – Mr. Anderson reported that registration for the lacrosse league will begin tomorrow; registrations for soccer and baseball has been completed.

Mr. Doyle announced the Planning Commission will meet on Monday, March 18, 2012 at 6:30 p.m.
