Mayor Schlegel announced that November is Epilepsy Awareness month. The Mayor introduced Haley, a young girl with Epilepsy. Mayor Schlegel announced there will a fund-raising event to raise funds for a service dog for Haley. The Mayor also said there is House Bill # to allow awareness and training in classrooms.

Mayor Schlegel reported that Robert Zunich is resigning from the Plum Borough Planning Commission after volunteering on their Board for thirty-eight (38) years. The Mayor thanked Mr. Zunich for his service to the community.

Motion was made by Mr. Dern, seconded by Mr. Seitz, to accept a bid for rock salt from Cargill Inc., through the South Hills Council of Governments, at a cost of \$82.24 per ton. Unanimously approved.

Motion was made by Mr. Dern, seconded by Mr. Seitz, to adopt Ordinance No. 943-19 vacating Elwood Avenue Extension in accordance with Section 1731 of the Borough Code. Unanimously approved.

Motion was made by Mr. Dern, seconded by Mr. Odom, to approve the Stormwater Task Force Charter and Guidelines as presented. Unanimously approve.

Motion was made by Mr. Dern, seconded by Mr. Odom, to add to the agenda the sale of an out-ofservice leaf vacuum. Unanimously approved.

Motion was made by Mr. Dern, seconded by Mr. Majernik, to authorize the sale of the 2001 Old Dominion Leaf Vacuum to the City of New Kensington for \$7,600. Unanimously approved.

MAYOR'S REPORT – Mayor Schlegel reported there were 1,065 calls in October; there were seven overdoses with four resulting in deaths; the ATS radar trailer was deployed to New Texas Road and it was noted that 85,027 vehicles traveled one way.

COMMITTEE REPORTS 40-19

INTERGOVERNMENTAL COOPERATIVE COMMITTEE WITH PLUM SCHOOL DISTRICT – No meeting has been scheduled.

FINANCE – Mr. Majernik reported revenues of \$746,481 and expenditures of \$772, 409; EIT collections are at 83% of budget; the Finance Director and Borough Manger met with department heads to review their 2020 budget submissions and the Borough's Tax Anticipation Note for 2020 will be \$2.5M.

ROADS, EQUIPMENT AND GROUNDS – Mr. Dern reported the East Oakmont stormwater project phase I has begun as well as the pipe replacement at HPFD; the 2019 paving projects in Holiday Park and Boyce Park have been completed, the leaf pickup continues and new street signs have been replaced as needed.

PUBLIC SAFETY – Mr. Brian Malone of Plum EMS reported they responded to 267 calls; the department conducted child passenger safety checks, one infant crib was donated, and a flu vaccine clinic was conducted.

ECONOIC DEVELOPMENT/PLANNING – Mr. Odom reported 114 permits were issued resulting in revenues of \$4,884.50; planning staff attended the PA DEP pre-construction meeting for the Renton Mine Fire Project and the Borough Solicitor worked on issues related to the vacation of Elwood Avenue Extension.

PARKS AND RECREATION – Mr. Seitz reported that Logans Ferry Park will be updated in 2020; Renton Park will also be updated in 2020; Allegheny County has not given an exact date on the opening of the dog park and restoration work has begun on ballfields #1 and #3 at Plum Creek Park.

Mr. Seitz announced that Christmas at Plum Creek will be celebrated on Thursday, December 5th. A new feature for this year will be a Santa's Shoppe. Mr. Seitz said there will be a Borough Bonfire on December with s'mores.
